**FURTHER BE IT RESOLVED**, that a Grant Deed and its terms and conditions do not constitute a trust by a trustee. Trustee will have their own individual trust to open and independent holding trust/storage unit.

**FURTHER BE IT RESOLVED**, that the trustee will own their own independent holding trust, not the storage unit itself. The storage unit is managed and held by the Society board, by authority of the Society members.

**FURTHER BE IT RESOLVED**, that these terms and conditions will allow the trustee to create an LLC of the ALL CAP NAME, via THE REIGN OF THE HEAVENS SOCIETY POST.

**BE IT RESOLVED**, that a motion was carried by the reign of the heavens society members that these United States International Lawyers Association of the reign of the heavens society, is to be involved and support the Human Rights Tribunal International.

**BE IT RESOLVED**, that a motion was carried by the reign of the heavens society members that affirmed International Notary's for the Government for The United States of America are eligible to hold a seat on the Human Rights Tribunal International.

**BE IT RESOLVED**, that a motion was carried by the reign of the heavens society members that the Ministers on the Human Rights Tribunal International are as follows;

April Hayes: representing the women's point of view.

John Harold Fulks: representing the Caucasian point of view.

Samuel German Valencia: representing the Latino point of view.

Moses Brian Moss: representing the African American point of view.
